## <u>Section 4: Local Implementing Agency (LIA)</u> <u>Information</u>

As you identify LIAs to join this effort, keep the long-term goal in mind: to scale with all LIAs. Consider engaging a diverse cadre of LIAs that reflect the diversity of your home visiting system (e.g., model, geography, size, ages of children served) and/or work closely with diverse populations. Striving for diversity now will help you avoid surprises as you continue to scale in subsequent years.

# Please note, a team's level of CQI experience and knowledge does not preclude participation.

Below we offer suggestions on how many LIAs to include in your scale efforts. We recognize that capacity varies across awardees. We encourage you to participate with the number of LIAs that makes sense for your team.

- Awardees with three or fewer LIAs should have all LIAs participate
- Awardees with five or fewer LIAs should start with a minimum of three LIAs

- Awardees with 6-19 LIAs should start with a minimum of half their LIAs
- Awardees with 20 or more LIAs should start with a minimum of 10 LIAs
